AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF BALLWIN TO ENTER INTO AN AGREEMENT ON BEHALF OF THE CITY WITH THE CITY OF MANCHESTER RELATING TO THE PROVIDING OF POLICE DISPATCHING SERVICES FOR THE CITY OF MANCHESTER.

WHEREAS, under the provisions of sections 70.210-70.325, inclusive, RSMo., the City of Ballwin is empowered and authorized to contract and cooperate with other municipalities for a common services; and

WHEREAS, the City of Manchester desires police communication services by the Ballwin Police Department; and

WHEREAS, the City of Ballwin has the ability to provide such communication services;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BALLWIN, MISSOURI, AS FOLLOWS:

- Section 1. The Mayor of the City of Ballwin is hereby authorized and directed to sign, on behalf of the City of Ballwin, an agreement with the City of Manchester, Missouri, providing for police communication services for the City of Manchester by the Ballwin Police Department, a copy of which is attached hereto and incorporated herein by reference as Exhibit A.
- Section 2. The period for which special police services shall be rendered to and for the City of Manchester shall be from January 1, 2017, through December 31, 2021 subject to annual appropriations by the City of Manchester, and a one hundred-eighty (180) day notification of cancellation, in writing, by either party.
- Section 3. The cost of providing police dispatching shall be based upon the activity formula attached and incorporated into Exhibit A. The activity formula categories will be reviewed annually and may be adjusted annually based on the results of an audit performed by the City of Ballwin. A copy of the audit shall be provided to the city of Manchester. Fees shall be adjusted upwardly and/or downwardly base on such audit.
- Section 4. The Agreement shall be in the form, language and contain the figures set forth in Exhibit A.
- Section 5. All ordinances or parts of ordinances in conflict herewith are to the extent of such conflict repealed.
