AN ORDINANCE PROVIDING FOR THE ERECTION OF TRAFFIC CONTROL SIGNS AND AMENDING THE ORDINANCES PROVIDING FOR THE LOCATIONS THEREOF

WHEREAS, the Public Works Department conducted a survey to determine the location of traffic control signs within the City of Ballwin and determined that the current Ordinances need to be amended to reflect actual existing locations and locations for new traffic control signs.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BALLWIN, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

Section 1, Sec. 15-480. – Schedule E of the Code of Ordinances of the City of Ballwin shall be repealed and replaced with the following:

Sec. 15-480. - Schedule E—Stop intersections and locations.

In accordance with the provisions of section 15-229 and when signs are erected giving notice thereof, drivers of vehicles at the intersections or locations listed in this schedule shall stop their vehicles as specified in this schedule:

Section 2, Sec. 15-482. – Schedule G of the Code of Ordinances of the City of Ballwin shall be repealed and replaced with the following:

Sec. 15-482. - Schedule G—Parking prohibited at all times.

In accordance with the provisions of section 15-268 and when signs are erected giving notice thereof, no person shall park a vehicle at any time upon any of the streets or parts thereof described in this schedule:

Street or Part Thereof Where Parking Prohibited

Andrews Park Way, both sides along its entire length from Seven Trails Drive to Ballpark Drive

Applegate Lane, both sides, from Birchwood Drive to a point 300 feet west of Birchwood Ballpark Drive, both sides along its entire length.

Ballwin Commons Drive north side from Ramsey Lane intersection to Solon Drive intersection, south side from Old Ballwin Road Intersection to Coachgate Lane intersection

Barker Lane, either side, from Ries Road to 139 Barker Lane

Baxter Road (east side) between a point 185 feet south of Hill Trail to the intersection of Baxter Road and Hill Trail

Birchwood Drive, both sides, between Applegate Lane and Manchester Road

Brass Lamp on north side of street from 411 Brass Lamp west to Morewood Court

Brass Lamp on north side of street from 423 to 427 Brass Lamp

Brass Lamp Drive on south side of street between Morewood Drive and Brass Lamp Court

Burtonwood, between no parking signs placed on the west side of the street in the vicinity of and opposite of 110 Burtonwood

Claymont east from Northmoor to Baxter on both sides of Claymont
