



HISTORY OF BALLWIN

allwin is a unique name for a City. In fact, it is the only City in the United States with its spelling (BALLWIN, NOT BALDWIN). The City was founded by John Ball, son of James Ball and Mary Bray Ball of Virginia and Kentucky. His father, James, who came to America from Dublin, Ireland, served in the 4th and 8th Virginia Regiments during the Revolutionary War. Because of his military service, he was given a military land warrant and moved to this new land in Kentucky after the war. Reportedly, James was a friend of Daniel Boone.

Around 1797 or 1798, our Founder, John Ball, moved to the West St. Louis County area, possibly at the same time as the Daniel Boone party moved to and settled in the St. Charles, Warren County areas. Records now preserved in Jefferson City show the transfer of title of about 400 acres of land along Grande Glaize Creek to John Ball in February, 1800. This is the first official record of John Ball in the West County area.

Since John Ball's property claim was derived originally from a Spanish land grant, and was land that was at the time under Spanish rule, the Louisiana Purchase raised doubts about property ownership. It took several hearings and appeals and ten years for John Ball to clear his claim to the land that would eventually become the town of Ballwin.

In 1826, Missouri moved its capitol to Jefferson City. Soon there was a need for an overland mail route between St. Louis and the new capitol. Fortunately, this new road was established along a route that passed by John Ball's property. After the road became established, (known at times as Jefferson Road, Market Road and Manchester Road), John Ball decided to capitalize on the accessibility it provided for his property, and laid out a town.

The town was originally recorded as "Ballshow", but two days later, on February 9, 1837, Ball amended the recorded plat to be named Ballwin. No one knows for sure why the name was changed, but one of John Ball's great grandsons says it was the result of a rivalry with neighboring Manchester. John Ball saw great things ahead for his new town and was confident that it would "win out" in reputation and growth over its older and more prominent neighbor, two miles to the east. Hence the "win" was incorporated into the name.

In the years that followed, Ballwin grew from the town John Ball knew with only a few homes and businesses, to a small village of 750 people when it was incorporated on December 29, 1950, to a thriving City of about 30,000 today (2010 Census). John Ball's vision of Ballwin as a leading City in the West County area has been realized. If you would like to learn more about John Ball and other stories of Ballwin's past, Ballwin history books may be purchased at the Government Center for \$5.00 and the updated edition for \$20.00 plus tax.

CITY SERVICES AND INFORMATION BUSINESS AND COMMERCE GENERAL

The City of Ballwin is a fourth class city under Missouri law with a Mayor-Aldermanic-City Administrator form of government. The Board of Aldermen consists of eight members, two Aldermen from each of four wards. The Mayor and Aldermen serve two-year terms, with four Aldermen being elected each year. The City Administrator is the chief administrative official of the City and is responsible to the Mayor and Aldermen for the administration of the City government.

The City Administration is divided into four departments: Administration, Parks and Recreation, Police, and Public Works.

The Board of Aldermen meet on the second and fourth Mondays of each month at 7:00 p.m. All meetings are held in the Board Room of the Donald "Red" Loehr Police & Court Center, 300 Park Drive, and are open to the public. All citizens are welcome to attend.

Residents of Ballwin are afforded an equal opportunity to participate in the programs and services of the City of Ballwin regardless of race, color, religion, sex, age, disability, familial status, national origin or political affiliation. If you are a person that requires an accommodation, please call (636) 227-8580 or (636) 227-5200 or 1-800-735-2466 (Relay Missouri) no later than 5:00 p.m. on the third business day preceding the hearing. Offices are open between 8:00 a.m. and 5:00 p.m. Monday through Friday.

PLANNING AND ZONING

Planning and zoning questions should be directed to either the Assistant City Administrator/City Planner or the Code Enforcement Supervisor at (636) 227-8580. These individuals handle the administration and enforcement of the City's Zoning Code.

The Planning and Zoning Commission is a ten-member board, appointed by the Mayor and Board of Aldermen. Its principal responsibilities are: consideration of changes to the Zoning Ordinance, Comprehensive Plan and zoning map, and review of petitions for Special Use Exceptions. All recommendations are passed on to the Board for final consideration.

The Planning and Zoning Commission meets on the first Monday of each month at 7:00 p.m. in the Board Room in the Donald "Red" Loehr Police and Court Center.

BOARD OF ADJUSTMENT

The five-member Board of Adjustment meets once a month on the third Wednesday at 7:00 p.m., depending on whether they have received any appeal petitions. The Board hears appeals and makes decisions on whether a variance should be granted to the provisions of the zoning, building and housing codes. Contact the Code Enforcement Supervisor or Assistant City Administrator for information at **636-227-8580**.

CITY LICENSE INFORMATION

The City of Ballwin requires that all business operations conducted within the city limits obtain a license. These licenses are based upon gross annual receipts for retail trade, non-retail, and a fixed rate per square foot of floor area for manufacturing. Licenses are renewed annually on January 1st for manufacturing and April 1st for all others. Information or licensing can be obtained from the Finance Officer or the Assistant City Administrator at **636-227-8580**. Each business is entitled to one resident I.D. card which permits the bearer to use Ballwin's recreational facilities at resident rates.

Some business uses are not allowed in certain zoning districts, or are more tightly restricted through the use of the Special Use Exception process. Information on this aspect of conducting a business within Ballwin can be obtained from the Assistant City Administrator or the Code Enforcement Supervisor.

RESIDENTIAL BUSINESS ACCESSORY USE

A business may be conducted from a residential location provided that the business is incidental and accessory to the primary use of the property which is residential. This incidental nature is characterized by remaining unobtrusive to casual view from surrounding properties and having no negative impacts on the neighborhood. Licenses for residential businesses are not required. Detailed information on residential business accessory uses can be obtained from the Assistant City Administrator or Code Enforcement Supervisor.

MUNICIPAL COURT

Ballwin's Municipal Court usually holds its sessions on the 2nd and 4th Tuesday of each month at 5:30 p.m. at the Donald "Red" Loehr Police and Court Center, 300 Park Drive in Vlasis Park. The Court office for payment of tickets is located in the Government Center at 14811 Manchester Road. For information about court dates, traffic tickets, or other court matters, contact the Court Clerk 8:00 a.m. – 5:00 p.m. at 636-227-9468.

SOLICITATION PERMITS

The City of Ballwin requires anyone wishing to do door-to-door sales or charitable solicitation within the City of Ballwin to have a permit issued by the Ballwin Police Department. Charitable and non-profit organizations must provide proof of charitable exemption by the Internal Revenue Service. A list of the names and addresses of the solicitors must be provided with the application, along with the permit fee. If you are bothered by someone soliciting in your neighborhood, you can call the Ballwin Police Department to ascertain if the solicitor has a permit. If they do not have a permit, they will be required to cease soliciting upon notification by a Ballwin Police Officer. Solicitation is prohibited where "No Trespassing" or "No Solicitors" or a similar sign has been posted. The telephone number to call to check on solicitors is the **Police Department at 636-227-9636**.

SPECIAL EVENT PERMITS

Ballwin businesses may obtain a special event permit for events such as sidewalk sales or other promotions held outside an enclosed building. A maximum of four special events are permitted each calendar year. Residential block parties also require a special event permit. To fill out an application, contact the **Ballwin Police Department at 636-227-9636**.

STREET TREES

Street trees are defined as trees and woody shrubs in excess of 30 inches high, growing or located on land within the right-of-way lines, on either side of all City streets, avenues, or ways within the City. The right-of-way is City-owned property, which generally begins at the curb and ends at a spot approximately 12 feet from the curb, toward residential property.

In the City of Ballwin, the Parks Department will trim or remove dead trees in the right-of-way located between the sidewalk and the curb.

Per City ordinance, living trees in the right-of-way may not be removed or pruned without City approval. Residents interested in planting a tree between the sidewalk and the street should contact the Parks & Recreation Department at 636-207-2423 for a list of approved trees.

Other items in the right-of-way are the property owner's responsibility. Bushes, flowers and mailboxes must allow for adequate traffic visibility and passage of vehicles and pedestrians on the sidewalks. Grass must be kept to a height below 6 inches.

WEST COUNTY CHAMBER OF COMMERCE

BUILDING AND INSPECTIONS

BUILDING PERMITS



Building permits are required for all kinds of construction, including room and garage additions, tool sheds, fences, decks, satellite dishes and swimming pools. Before beginning on any of these items, it will be necessary that a building permit be obtained. If you have any questions about what is needed to obtain a permit or to obtain an information booklet,

please contact the Building Inspections Department at **636-227-2129** or **636-227-8580**.

HOUSING INSPECTIONS / OCCUPANCY PERMITS

In the City of Ballwin, all commercial properties and dwelling units must be inspected and certified for compliance with the Ballwin Housing Code before they can be sold or the occupant changed New occupants are required to obtain an Occupancy Permit before taking up residency in any commercial property, house, condominium or apartment. Inspection applications and Occupancy Permits can be obtained at the Government Center. Contact the Housing Inspector (636-227-2129) for details.

PROPERTY MAINTENANCE

The City of Ballwin, in addition to its Housing Code enforcement program, enforces two other property maintenance codes. These codes prohibit the accumulation of trash and the growth of vegetation over six inches in height. For more information or to report a violation, contact the Building Inspector at 636-227-8580.

LEGIBLE ADDRESS REQUIRED

In cooperation with the local Fire Protection Districts and the West County Chamber of Commerce, the City of Ballwin requires all homes to have a legible address. In addition, all businesses must have their address posted on both the front and back of their business. This requirement is enforced whenever the City inspects a housing unit or business on change of occupancy.

LOCAL NEWS

STREETS

PUBLIC WORKS: pw@ballwin.mo.us SNOW EMERGENCY PARKING

Ballwin Ordinance #1375 prohibits the parking of vehicles on City streets when the City is under a snow emergency. A snow emergency occurs whenever snow accumulates to two inches or more or during freezing rain or ice. This prohibition is in effect until the street has been cleared. Please be aware of winter weather forecasts of snow or freezing rain, and remove your cars from the street. Parked vehicles impede snow and ice removal efforts, and the Police Department will issue tickets to violators.

SNOW POLICY AND PROCEDURES



Our policy is to clear all public streets within the city as quickly as possible. The procedure is to salt all the streets just before the snow or freezing rain can adhere to the pavement. Plowing will begin when snow accumulation becomes s safety issue and to improve the effectiveness of salt.

You can call **636-227-9000** to speak directly to the Public Works Department. The normal hours are Monday through Friday, 7:00 a.m. to 3:30 p.m. However, during a snow storm, you may call at anytime while the snow trucks are plowing and salting.

POTHOLES ETC.

If you notice any potholes, sidewalk tripping hazards, or other street related problems in your neighborhood or around the City, please report them by calling the Public Works Department at **636-227-9000**. The Public Works Department also has the responsibility for replacement of damaged or missing street signs. Your help in reporting these conditions will be appreciated. Sewers are maintained by MSD (Metropolitan St. Louis Sewer District). Manchester Road is maintained by MoDOT (Missouri Department of Transportation. Baxter Road, Clayton Road, New Ballwin Road (south of Twigwood Dr.), Kehrs Mill Road (north of Clayton Road) and Big Bend are maintained by St. Louis County.

WALKING THE DOGGIE

A reminder that animal feces must be picked up immediately from public property, street right-of-way, alley, sidewalk, condominium or subdivision common area or private property of another; and the proper pickup equipment be immediately accessible to the owner or handler of the animal for proper disposal.

EXCAVATION PERMITS

Anyone interested in excavating within the City's street right-of-way, which in most cases extends 12 feet back from the curb, must first obtain an Excavation Permit. Work which may require a permit includes lawn irrigation systems, driveways and sanitary sewer repairs. If you have any questions, call the Public Works Department at (636) 227-9000.


LEAF COLLECTION



The curbside leaf collection is only provided to customers of the City's <u>contracted</u> waste hauler. Properties that have a <u>separate</u> contract are excluded from the City's curbside leaf collection program. The trash hauler, as part of their yard waste collection, will also pick up leaves provided they are put in yard waste bags or separate containers.

SOLID WASTE & RECYCLING

TRASH REMOVAL



Republic Service at 636-947-5959 to arrange for pickup and billing. Yard waste, recycling and bulky pickup are included in the price. City ordinance prohibits placing and leaving trash cans, bags of trash, or bundles of yard waste at the curb at any time other than on the day of pickup. Trash cans should always have lids in place to keep trash in the can. Construction materials or the materials that result from home remodeling projects will not be collected as part of the normal trash or bulk trash. You can call Republic or go to their website to arrange to have this picked up for an additional charge. To ensure pickup, please have your trash out by 6:00 a.m. on your service day. To dispose of paint, it should first be dried out and hard. Sand or kitty litter can be used for this. You should place the paint cans out next to your trash can, leaving the lids off so the driver can see it is dry.

HOLIDAY TRASH PICKUP

Occasionally a regular trash pickup day will fall on a holiday. When this occurs, pickup will take place on the following day. If your regular pickup was normally scheduled for the day following a holiday, your pickup will also be a day later. On such days, pickups will not necessarily be at the normal time, so residents should make sure to get the trash out by 6:00 a.m. If the holiday falls on a Saturday or Sunday, your service will not be affected.

BULKY ITEM PICKUP

Bulky item pickup is limited to 2 items per month and those items should be put out only on your last pickup day of the month. Generally, any item which can be picked up by two people and does not exceed 150 lbs will be taken if it is placed at the curb. No construction materials, hazardous

wastes, large automobile parts, including tires or batteries, will be picked up. "White Goods", which include appliances and similar large metal items, require special handling. Although there is no additional charge for removal of these items, this pickup must be arranged by calling Allied Republic Service, Inc. at (636) 947-5959.

YARD WASTE PICKUP

As a part of the contract with Republic Service, Inc., yard waste, such as grass clippings, leaves, limbs, brush etc. (bundled in maximum 4' long by 24" in diameter with string or twine), will be picked up. Due to Missouri law, yard waste may not be put into landfills. It must be composted. This requires that all yard waste must be separated from trash and garbage and be placed in a container dedicated to these materials, or in biodegradable paper bags. Yard waste materials will not be picked up if they are mixed with regular trash. Yard waste put in plastic bags will not be picked up. Any branches over 6 inches in diameter will have to go with bulky trash. To ensure pickup, please have your yard waste out by 6:00 a.m. on your service day.

CURBSIDE RECYCLING PROGRAM



The refuse collection contract with Republic Services, Inc. includes curbside pickup of recyclables. The cost of this service is included in the residents' quarterly bill. As part of this program, Republic will deliver a recycling container to your house. This container can be filled with new spaper, junk mail, glass, aluminum cans, tin/steel cans

and plastic soda bottles and beverage containers and placed at the curb line for collection once a week. For more information or to obtain a recycling container, contact Republic at **(636) 947-5959**. To ensure pickup, please have your recyclables out by 6:00 a.m. on your service day.

Used motor oil is not included in this program. Contact your local service station or repair shop for disposal.

HOUSEHOLD CHEMICAL COLLECTION

St. Louis County now has a permanent household hazardous waste (HHW) drop off site located at the Lemay HHW Facility at 291 E. Hoffmeister in south St. Louis County, (on the grounds of the Metropolitan St. Louis Sewer District's Lemay Waste Water Treatment Plant). All county residents, including Ballwin residents, can use this site. PROGRAMS OFFERED BY THE BALLWIN POLICE DEPARTMENT

BICYCLE PATROL

Ballwin Officers who have completed the International Police Mountain Bike Association (IPMBA) training are assigned to the Bicycle Unit. The Bicycle Officer has the ability to access difficult areas, navigate through traffic congestion, and approach suspicious activity without audible warning. The unit focuses special attention in subdivisions, apartment complexes, parks, and commercial areas. They also patrol special events, such as "Ballwin Days".

COMMUNITY ORIENTED POLICING (COMMUNITY AFFAIRS UNIT)

COPS Officers work within the community by assessing situations and utilizing various resources to solve problems. Through analysis, the COPS Officer discovers why recurring incidents keep happening. The specific needs of citizens are more personally addressed through problem solving. Referrals are given to the COPS Unit by the fellow officers. Referrals include pre-delinquent counseling for parents and their children, issues with the elderly, problems in the neighborhood, etc.

SCHOOL RESOURCE OFFICER

This officer is assigned to work in the City's junior high school throughout the school year. The officer performs enforcement, prevention, and teaching duties. He/she acts as a liaison between the Police and the school. It is a cooperative effort between the Police Department and the school district to attempt to cover all areas of mutual concerns. The School Resource Officer provides a positive role model and opens the lines of communication for children, developing early bonds of trust and cooperation.

CITIZENS' POLICE ACADEMY

The Ballwin Police Department's Citizens' Police Academy provides participants with an in-depth look into the operation of the Ballwin Police Department and how law enforcement works within the criminal justice system. The classes meet weekly for 10 weeks. The Citizens' Police Academy program has been very successful across the nation in establishing

interactive communication between law enforcement and citizens. The Ballwin Police Citizens' Police Academy classes are conducted in the fall of the year.

BICYCLE RODEO AND REGISTRATION



A course is laid out for the children to learn rules of the road and safety measures. The bicycles are inspected for safety and a sticker is affixed to the bicycle with an identification number that will aid the Police Department in recovery if stolen.

HOME / BUSINESS SECURITY SURVEYS

In conjunction with neighborhood watch, a police officer will go to the home of any Ballwin resident and recommend safety measures aimed at helping secure their home from a possible break-in.

On request, surveys are also conducted in businesses in order to point out security improvements needed to avoid a crime being committed against them. These crimes include burglary, robbery, and shoplifting.

CRIMINOLOGY CLASSES IN SCHOOLS

A police officer will speak to classes on basic Criminology and rights in the Junior and Senior High Schools. Duties of a police officer and behavior of students when confronted by a police officer are also discussed.

D.A.R.E.

Drug Abuse Resistance Education is taught to fifth and sixth graders in all schools in the Ballwin Policing area. This is a 17-week drug education program which focuses on identification, self-esteem, alternatives, and ways to say no to drugs. A uniformed officer teaches each class for one hour a week for the entire 17 weeks.

DRUG AWARENESS FOR PARENTS AND CHILDREN (P.E.P. - POLICE EDUCATING PARENTS)

Literature describing various drugs and their effects are distributed upon request, and a police officer will speak to groups concerning current drug problems and possible solutions.

NEIGHBORHOOD WATCH

Subdivisions are given training on how to spot suspicious persons and vehicles, how to secure their own homes, and how to keep and help protect their neighbor's property.

OPERATION IDENT

This program is conducted in conjunction with Neighborhood Watch. Engravers are available, on loan, from the Police Department to citizens so they can mark their valuables. This helps deter theft and aids in recovery of property if stolen.

R-U-OK? (ARE YOU OK?) PROGRAM

This program is a service to our older residents and those in poor health that live alone. Participants in the program receive a computer generated telephone call once a day. When the call is answered, the participant receives a recorded message informing them of the reason for the telephone call, and the computer is reset to call the next day. If the call is not answered, an alarm at the Police Communications Center is triggered and a police officer is sent to the house to make sure everything is OK.

SELF-PROTECTION FOR WOMEN

An officer will speak to women's groups instructing them on the procedures to follow in order to avoid and deter personal attacks. In addition, a women's self-defense seminar is held each year.

SAFETY FOR CHILDREN - FINGERPRINTING

Children in pre-school through 6th grade are fingerprinted in order to possibly identify a child if he or she may be abducted. This is done on a yearly basis with the parents retaining the fingerprint cards. (The Police Department will not keep any fingerprint card on a child.)

TOURS OF THE POLICE DEPARTMENT

Tours are conducted of the Ballwin Police facility for organized groups of children. They are taught how to use the Emergency 911 number, and are given a sampling of what is involved with the day-to-day operation of a Police Department.

HUG-A-BEAR PROGRAM

The Ballwin Police, in conjunction with AT&T, keep on hand a supply of stuffed handmade bears. When officers respond to a call in which a child was injured or traumatized, the child is given a Hug-A-Bear.



RIDE-A-LONG PROGRAM



If someone is currently attending school and is pursuing classes in criminal justice or is involved in police functions or security, they may file a Ride-A-Long request with the Ballwin Police and ride with one

of the uniformed officers. Once a request is filed, it will be submitted for approval and the participant will be notified and scheduled to ride.

BUCKLE BEAR

Buckle Bear is the Ballwin Police's mascot which pays visits to schools, day cares, churches, and day camps. Buckle Bear wears a set of seat belts to demonstrate to the public the importance of "Buckling up for safety".

IN SAFE HANDS

This is a program to assist residents who have family members with special needs. These needs include, and not limited to, Alzheimer's, Dementia, Down Syndrome, and stroke victims. Often, people who fall into these categories have trouble communicating the information needed, should they get separated from their family and are located by the police. There is no age limit for this program. Any residents interested in this program are

asked to contact the Ballwin Police Department to obtain an application. The application asks for information on address, emergency contacts, pedigree, and a recent photo. There is no charge for this program.

INTERACTIVE 911 SIMULATOR

This is used during presentations at the police station or classroom presentations. Using the simulator telephone, a child participates in a question and answer dialogue with a realistic emergency operator. If you would like to schedule a tour or classroom presentation, call the Community Affairs Div. at 636-207-2367.

NATIONAL NIGHT OUT



Each year on the first Tuesday in October, the citizens of the Ballwin Policing area are asked to turn on all of their lights, lock their doors, and spend an hour outside with neighbors while taking a stand against crime.

RED RIBBON WEEK

One week in October every year is devoted across the United States as Red Ribbon Week. Everyone is asked to tie a red ribbon onto the antenna of their vehicle to symbolize a commitment to a drug-free, healthy lifestyle and to present a unified and visible commitment toward the creation of a Drug-Free America.

STUDENT SHADOWING / STUDENT INTERNS

The Ballwin Police are very supportive with those students trying to further pursue their career goals. The Ballwin Police work closely with the school districts, and when possible, will accept an intern to work at the Police Department. This not only fulfills a requirement for the student, but also it gives him or her the insight into their career choice of criminal justice.

55 ALIVE - DRIVING SAFETY FOR OLDER DRIVERS

The Ballwin Police Department, in conjunction with AARP, presents this program. It covers the effect of aging on a person's eyesight, hearing, and reaction times, and their effect on the ability to drive safely. The program offers ways to cope with these challenges. Persons attending the program may be eligible for insurance premium discounts with some companies.

WEB DETECTIVE

This is a program through the City's website to address questions concerning crimes and criminal proceedings. By logging onto www.ballwin.mo.us and clicking the Web Detective icon, residents can ask their questions and receive a response within a day.



BUSINESS RESOURCE OFFICER

The Ballwin Police Department's Business Resource Officer program is designed to enhance the relationship between the Police Department and the business community. The Business Resource Officer's primary role is to serve as a liaison between the City and the businesses and property owners. The officer works with the business community to address crime prevention efforts, quality of life issues, and other concerns related to City Government.

THE POINTE AT BALLWIN COMMONS, located on Ballwin Commons Circle, just off of Ballwin Commons Drive and Old Ballwin Road, is a state of the art recreation complex housing two full gymnasiums, an indoor track, full circuit weight system, cardiovascular equipment, free weight area, dance/aerobic studio, locker rooms, baby sitting room, concession area, game room, kids play area, and meeting rooms that hold up to 150 people.

The ID cards may be acquired year-round at The Pointe and during the summer months at the North Pointe Aquatic Center for \$5. The cards need to be renewed annually for a \$1 fee. To apply for a card or to renew an existing card, residents are required to provide proof of residency, which includes an unpaid gas, electric, water, or sewer bill, or the paid stub of one of these bills, and a copy of your most recent bank statement. 
WEST ST. LOUIS COUNTY PARKS

BUDER PARK: The only polo playing field in the St. Louis County park system and a model plane flying field are located in Buder Park on Valley Road near Hwy. 141 and I-44.

FAUST PARK - This park of historic interest contains the restored homes of Frederick Bates, the first governor of Missouri. The 98-acre park is located on Old Olive Street

Road, just north of I-64 (formerly I-40). It also includes the

Butterfly House.



WEST TYSON PARK - This park contains a wilderness camping area on 240 acres near the Meramec River. The park entrance is on Lewis Road just north of I-44.

LOVE MEMORIAL PARK - This 48-acre park, located at Manchester and Mason Road, contains picnic facilities, playground equipment, and an athletic field.

QUEENY PARK - This 569-acre park is one of the best equipped of the County parks. The recreation complex has an ice skating rink, swimming pool, playground, and tennis courts. There are 6½ miles of trails, most of which are available for horseback riding. The park is located north of Manchester Road and is between Mason and Weidman Roads.
