RE: G-Suite for Business/Virtru/CloudMigrator

DEPARTMENT: Administration

PROGRAM: Information Technology

RECOMMENDATION: Purchase G-Suite for Business accounts for all full-time

employees and Mayor & Aldermen. Include third-party encryption software called Virtru for Police and Court staff and CloudMigrator Migration software. The product pricing from Google and Virtru are the same regardless of vendor.

Professional services including implementation, migration

and training to be provided by Umzuzu.

EXPLANATION:

This is a budgeted project for 2018. The City will move from the onsite, server-based Exchange email system to the G-Suite for Business cloud alternative (gmail). G-Suite for Business offers much more than just email and calendar. Users will have access to a plethora of applications including Google Drive, Docs (like MS Word), Sheets (like MS Excel), Forms, Slides, Sites, Vault, unlimited mailbox storage, unlimited file storage, and many more features.

G-Suite for Business is not platform dependent. It will work with Apple iOS, Microsoft Windows, Androids, Chromebooks, etc.

All applications and accesses secured and administered from an Administrative console. All full-time employees will have a G-Suite account at \$10/month (145 employees).

Virtru is encryption software used in conjunction with gmail offering secure communication and is CJIS compliant. The Virtru product will added to Police and Court staff at \$5/month (61 employees).

CloudMigrator will take the existing Exchange user accounts and move them to the appropriate gmail account. This product is a one-time cost of \$10 per Exchange account (112 individual accounts).

Umzuzu will provide professional services including implementation, migration, and training for both end-users and Administrators (\$6,900). Umzuzu comes recommended by both City of Creve Coeur and City of Richmond Heights having assisted with their migrations to G-Suite (please see attached Umzuzu proposal and separate cost analysis).

- Umzuzu will migrate active Exchange mail, calendar, and contact data.
- Umzuzu will provide software and instruction to assist staff in the migration of local .PST data to G Suite user accounts.
- Umzuzu will coordinate the required DNS changes to facilitate Google Cloud domain verification and mail routing.
- Umzuzu will assist with the reconfiguration of email-enabled applications and appliances.
- Umzuzu will deploy the web-based G Suite Training.
- Umzuzu will provide 5, 20 person on-site training sessions over 2 days. Training will cover Gmail and Calendar. Client will provide training facilities and computers.
- Umzuzu will configure Exchange to facilitate dual email delivery for the purposes of a Phased Deployment.
- Umzuzu will assist in the configuration of email-enabled applications and devices
- Umzuzu will assist with Q&A, general troubleshooting, etc.
