LEGISLATION

BIII 5017- AN ORDINANCE GRANTING A SPECIAL USE EXCEPTION TO FUAD KHALIL FOR MIZAN PIZZA, FOR OPERATION OF A RESTAURANT WITH FRONT YARD PARKING. This ordinance is for a new pizza restaurant located at 15523 Manchester Road in Gordon Plaza.

Bill 5018- AN ORDINANCE GRANTING A SPECIAL USE EXCEPTION TO MIDWEST PETROLEUM COMPANY FOR FRONT YARD PARKING AND OPERATION OF A FUEL FILLING STATION WITH CONVENIENCE STORE AT 15302 MANCHESTER ROAD.

This ordinance is for a fuel filling station with convenience store located at 15302 Manchester Road at the corner of New Ballwin Road and Manchester Road.

Bill 5019- AN ORDINANCE APPROVING A ZONING CHANGE FROM COUNTY R-2 AND BALLWIN R-2 SINGLE FAMILY TO R-2 A FOR CLAYMONT, CLAYMONT COVE, CLAYMONT PLACE, CLAYMONT COURT, CLAYMONT ELEMENTARY AND ST. MARK PRESBYTERIAN CHURCH.

This ordinance is for rezoning the Claymont subdivision area from County R-2 and Ballwin R-2 Single Family to Ballwin R-2A. This rezoning was never completed when the subdivision was annexed several decades ago.

CONSENT ITEMS

Administration – Geotechnical Services for Parks Maintenance & Public Works Facility Staff recommends awarding the contract for geotechnical services for the new police station to SCI Engineering for \$27,838.

Public Works – Vlasis Park Site Furnishings

Staff recommends auctioning or selling City equipment and Vehicles listed above through an Auction service.
