INTRODUCED BY ALDERMEN UTT, FINLEY, STALLMANN, ROACH, FLEMING, LEAHY, KERLAGON, BULLINGTON

AN ORDINANCE AMENDING THE AMOUNT OF FEES CHARGED FOR CERTAIN RECREATIONAL PROGRAMS.

WHEREAS, the City of Ballwin has determined that fee rate increases for certain recreational programs are appropriate after a review of the market and because such increases may generate additional revenues.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BALLWIN, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

<u>SECTION ONE:</u> Section 18-10 (1) of the Code of Ordinances of the City of Ballwin shall be repealed and replaced with the following:

SECTION TWO: Section 18-12 of the Code of Ordinances of the City of Ballwin shall be repealed and replaced with the following:

Sec. 18-12.-Bank Draft System.

Fees for the community center may be paid according to the following monthly schedule for annual passes purchased by direct debit to an existing account. Direct debit accounts shall include a \$2.00 per month charge for the service. A \$20.00 activation fee shall be charged as a one-time expense to process the new pass. The activation fee shall be paid along with the first month's payment at the time of registration.


