SUBJECT: THE VILLAS AT MEADOWBROOK SUBDIVISION

During the week of January 11, 2016 the developer's surveyor set the right-of-way monuments along both streets in this subdivision. The sidewalks at the traffic calming islands were found to be outside the right-of-way. The sidewalks were constructed following the pavement curbs, instead of following the right-of-way per the approved plans.

In order for the City to maintain these sidewalks the developer obtained sidewalk easements from affected owners. These easements allow the City to improve, construct, repair and maintain the sidewalks. I recommend an ordinance be passed accepting these easements prior to accepting the streets and sidewalks for City maintenance.


