T² Traffic & Transportation is pleased to submit the following Phase 1 signage assessment for the City of Ballwin, Missouri. This report is intended to provide an initial review of R1-1 ("stop") signage within the City of Ballwin, focusing on specific locations identified by the Ballwin Police Department (PD). This study is the first phase of the Signage Assessment project, resulting in recommendations for half of the twenty-six individual signage locations and outlines a second phase of the project to complete a more robust engineering assessment of the remaining locations and a Policy Manual for the City.

### **Project Overview**

The City of Ballwin is performing an assessment of its current roadway network stop (R1-1 regulatory) signage throughout the City. The goal is to broadly look at installation throughout the City, scrutinize particular locations identified by the Ballwin Police Department (PD) and document approval procedures for use when questions and requests for additional stop signs arise. The effort requires investigation of existing traffic conditions, signage, compliance and issues with the ultimate goal of enhancing safety and efficiency throughout the network. Furthermore, future plans and potential for the system will be considered in an effort maximize the applicable lifetime of any recommendations and strategies for implementation.

During the proposal phase of the project, the City determined the project would be completed in two phases in an effort to obtain and use project funding support via a Traffic Engineering Assistance Program (TEAP) funding grant from the Missouri Department of Transportation (MoDOT). Applications for this program were due September 20, 2019 and awards will be announced November 8, 2019. Therefore, the bulk of the technical analysis would be performed in Phase 2 of the project (ideally utilizing a TEAP grant) with Phase 1 serving as a precursor to summarize the information to date and outline the study process for the City. (Note: although it was desirable, due to the timing of Phase 1 selection, there was limited ability to compile information to support the TEAP application).





<u>Phase 1</u> of the project includes the overall review of stop signage throughout the City; documentation of existing issues, including a prioritized list of individual site locations to be evaluated with related data and information needs; and a scope and fee estimate to complete the evaluations and prepare an implementation policy in a subsequent phase. The preliminary investigation is documented in this letter report to serve any consultant or timeline for the second phase.

Preliminary assumptions for <u>Phase 2</u> are: data will be collected, and detailed analysis performed for selected sites, resulting in a prioritized list of recommended modifications and any associated costs. A detailed policy for the implementation of future stop sign implementation will be prepared in coordination with the City and Ballwin Police Department staff.

### **Existing Conditions**

The City of Ballwin is a great place to live, work, and raise a family. The City has been named multiple times as "One of America's Best Places to Live" by Money Magazine and has also been identified as one of the safest cities in America. One of the City's strengths is its robust roadway network, with access to three interstates and as many prominent State or County routes. There is a genuine street hierarchy, a relatively dense pedestrian network, and an emerging bicycle network. The existing roadways are well-maintained, and transportation and access are routinely listed as benefits by City residents.

Recently, City staff has received numerous requests from residents for additional and/or enhanced stop signs within the City. In addition, the Ballwin PD has an on-going list of stop sign locations that need to be investigated. This project aims to study the locations identified by the PD and residents as well as create a Policy Guide for the approval and implementation of future stop signage within the City.

### PRIORITY STUDY LOCATIONS

During the scoping phase of this project, Ballwin PD shared an inventory of the, approximately, 426 stop (R1-1 regulatory) signs within the City (attached as **Appendix A**). Within this list, the City has flagged:

- 31 high violation signs (yellow)
- 6 high crash location signs (red)
- 1 "not useful" signage location (green)

In addition to the existing signage, the City has identified:

• 3 additional locations where a stop or pedestrian accommodations have been requested (aqua)





Many of the stop signs in question are located at common intersections (i.e. both main road and crossroad). Therefore, this list results in 26 individual study locations to be investigated, as mapped in **Figure 1**. The Phase 1 project team met with City and Ballwin PD staff multiple times during the proposal and selection phase to obtain project information, including a "ride-along" with PD Department of Traffic Safety to visit and discuss the priority locations identified by the City. A summary of priority locations, details, and PD and observation notes are shown in **Table 1**.

These individual study locations are spread throughout the City, primarily located in neighborhoods at the intersection of local streets owned and maintained by the City of Ballwin. The exception is one location on an arterial owned and maintained by St. Louis County Department of Transportation:

• New Ballwin Road at Oak Run Lane (pedestrian crossing requested)


At this location, all decisions in regard to the approval, design and installation of any new traffic control will be made by St. Louis County. The Phase 2 project team will need to approach the St. Louis County North/West Area Engineer to begin discussions regarding issues and potential solutions.

In addition, there are four locations on City streets that approach Manchester Road (MO Route 100) which is owned and maintained by MoDOT:

- Steamboat Lane (high-crash location)
- Ramsey Lane (high-violation location)
- Ballwin Manor Drive (no stop sign currently, potential addition)
- Lark Hill Lane (high-crash location)

Although the City has jurisdiction over these approaches, the Phase 2 team is also encouraged to reach out to the MoDOT Area Engineer for South-West St. Louis County in regard to any potential mitigation at these locations.

#### **EXISTING CITY GUIDANCE**

The City of Ballwin currently has limited official guidance regarding stop sign installation. There is an existing Policy adopted by the Board of Aldermen in February 1997, attached in **Appendix B**, but no further action since that time. The Ballwin Police Department has no additional policies or guidance.

The City Policy states that, for Arterial (and higher classified) Roadways, the warrants established by the Manual of Uniform Traffic Control Devices<sup>1</sup> (MUTCD) govern. For Collector Roadways, the Chief of Police and the City Engineer shall prepare a joint recommendation in regards to stop sign installations based on the (MUTCD) warrants, accident history, sight distance, and/or other concerns (note: the City of Ballwin currently contracts with the City of Ellisville for City Engineering services). However, for residential streets, the policy requires a slightly higher accident rate or minimum traffic volumes plus physical factors plus resident support or a vote of the Board of Aldermen – there is no reference to the MUTCD.

Section 1 of the Policy lists roadway classifications as defined by the City of Ballwin, and Section 3 designates routes by classification. According to the policy, several of the project locations are located on City Arterials: Holloway Road, Kehrs Mill Road, Steamboat Lane, West Skyline Drive, Ries Road, Ramsey Lane, and New Ballwin Road. The local Metropolitan Planning Organization (MPO) for the St. Louis region, The East-West Gateway Council of Governments (EWGCOG), is responsible for maintaining and updating the region's Roadway Functional Classification System. **Appendix C** includes EWGCOG's Functional Classification Maps that cover the City of Ballwin. According to this official classification, all but one of the study intersections are located on Collectors or Local streets; the exception is the potential pedestrian crossing of New Ballwin Road (at Oak Run Lane), which is a minor arterial.

### **Phase 1 Findings**

In general, the City of Ballwin's stop signs appear to be follow industry guidelines. Signage is located and installed appropriately and looks well-maintained. The possible exception is some inconsistency in placement, which is a common occurrence in cities. In the 1980's-1990's stop signs were frequently installed in an effort to reduce vehicle speeds. However, empirical evidence has indicated that numerous stop signs can lead to noncompliance (rolling or running stops) and increased speeds (drivers attempt to "recapture" time lost). And the MUTCD explicitly states "YIELD or STOP signs should not be used for speed control." The City Policy approved in February 1997 may have been an attempt to regulate such a practice of overuse of stop signage installation.

Many of the twenty-six individual study locations are questionable as to whether they would meet current warrants. According to the City Policy (**Appendix B**):

- existing conditions must meet the federal warrants listed in the MUTCD, or
- there are three (3) or more reported accidents in the past two years (of a type susceptible to correction by installation of a stop sign), or
- there is a sight-distance issue, or
- there are other concerns following an engineering study; traffic volumes are considered if the minor-street volumes exceed 50% of the major roadway

The City Policy generally follows the guidelines within the MUTCD, with the latter providing more specific parameters. Some of the applicable guidance within the MUTCD includes the recommendation that stop signs are considered for minor-street approaches where the traffic volume on the major roadway exceeds 6,000 vehicles per day and that multi-way stop control is intended for locations where the volume of traffic on the intersecting roads is approximately equal and meets specified thresholds.

Referring to both the City Policy and MUTCD guidelines, none of the locations appears to have a sight-distance issue that would warrant the existing stop sign. However, three of the study locations potentially meet accident history warrants:

- Location 6: Holloway Road and Kehrs Mill Road
- Location 8: Lark Hill Lane at Manchester Road
- Location 19: Steamboat Lane at Manchester Road



In addition, there are ten additional locations where removal of signage should not be considered due to the hierarchy of intersecting roadways or the presence of pedestrian facilities. Instead, mitigation alternatives aimed at improving compliance at these intersections should be identified. These locations are:

- Location 1: Ballpark Drive and Kehrs Mill Road
- Location 2: Castle Pines Drive and Castle Glen Court
- Location 4: Country Club Drive and Briarwyck Drive/Claymont Place Drive
- Location 7: Holloway Road and Park Drive/Stoddards Mill Drive
- Location 13: Ramsey Lane at Manchester Road
- Location 14: Ries Bend Road and Ries Road
- Location 15: Ries Bend Road and Ries Road
- Location 16: Ries Road and Caravel Court/Twigwood Drive
- Location 20: Westglen Village Drive and Westrun Drive
- Location 24: Ballwin Manor Drive at Manchester Road (proposed)

Therefore, an engineering study is recommended for the thirteen remaining study intersections to confirm whether stop signs are warranted and to investigate alternatives as necessary. These locations to be further evaluated in Phase 2 of the Ballwin Signage Study are:

- Location 3: Cleta Drive and Asilomar Court
- Location 5: E. Skyline Drive and W. Skyline Drive
- Location 9: Lennox Drive and Mayfair Drive
- Location 10: Oakwood Farms Lane and Jacob Lane
- Location 11: Oakwood Farms Lane and Oakbriar Farm Drive
- Location 12: Ramsey Lane and Vail Court
- Location 17: Ries Road and Jefferson Avenue
- Location 18: Steamboat Lane (Pedestrian Crossing)
- Location 21: Westrun Drive and Terrington Drive
- Location 22: Windcliffe Drive and Towercliffe Drive
- Location 23: Windcliffe Drive and Portwind Place
- Location 25: Oak Run Lane at New Ballwin Road (proposed "mid-block" pedestrian crossing; St. Louis County jurisdiction)
- Location 26: Del Ebro Drive and Nottingham Drive (proposed)



#### **Phase 1 Recommendations**

The following paragraphs include recommendations to improve compliance and safety at those thirteen locations where it is recommended that the existing signage should remain as well as recommendations for interim treatments at the remaining locations where an engineering study is recommended.

### SIGNAGE CHANGES

Of the thirteen intersections where it is recommended that signage should remain, there are potential changes or improvements to the signage that could enhance compliance and safety.

- <u>Location 4: Country Club Drive and Briarwyck Drive/Claymont Place Drive</u> school zone signage and/or treatments
- <u>Location 6: Holloway Road and Kehrs Mill Road</u> LED-enhanced stop signs to additional legs of intersection where non-compliance continues to be an issue; increase sign sizes to 36"x36" on to multilane approaches
- <u>Location 7: Holloway Road and Park Drive/Stoddards Mill Drive</u> adding LED-enhanced stop signs on Holloway Road approaches
- <u>Location 8: Lark Hill Lane at Manchester Road</u> LED-enhanced stop sign on Lark Hill Lane approach
- <u>Location 14: Ries Road and Ries Bend Road</u> the Yield sign for the channelized right-turn should be located on the RIGHT side of the roadway (it is located in the island to the left of the channelized travelway). Relocate the sign to the right side of the pavement. Consider LED-enhanced stop signs for the northbound and/or southbound approaches if compliance does not improve
- <u>Location 16: Ries Road and Twigwood Drive/Caravel Court</u> increase sign sizes to 36"x36" on multi-lane approaches, install LED-enhanced stop sign on southbound approach
- <u>Location 19: Steamboat Lane at Manchester Road</u> increase sign size to 36"x36" for multilane approach, install LED-enhanced stop sign
- <u>Location 24: Ballwin Manor at Manchester Road</u> add stop sign (and stop bar striping) to Ballwin Manor approach



#### STRIPING CHANGES

Traffic control at several of the locations could be enhanced by adding or refreshing the roadway striping at the intersection. Lane markings and stop-bars provide another visual cue to drivers to slow and/or stop at an intersection and be aware of opposing traffic. Pedestrian crosswalks can enhance this effect by alerting drivers to a shared space while also providing facilities for non-motorized road users. Added or refreshed striping is suggested for the following study locations:

- <u>Location 1: Ballpark Drive and Kehrs Mill Road</u> add a pedestrian crosswalk across the south leg
- <u>Location 2: Castle Pines Drive and Castle Glen Court</u> add a pedestrian crosswalk across the north leg; consider adding a pedestrian ramp and crosswalk across the east leg
- <u>Location 4: Country Club Drive and Briarwyck Drive/Claymont Place Drive</u> add pedestrian crosswalks across north and east legs of intersection and refresh existing striping, moving back stop bars and stop signs if necessary for new crosswalks
- <u>Location 9: Lennox Drive and Mayfair Drive</u> add stop bars and centerline striping on all approaches
- <u>Location 10: Oakwood Farms Lane and Jacob Lane</u> add stop bars on all approaches and centerline striping on Oakwood Farms Lane approaches
- <u>Location 11: Oakwood Farms Lane and Oakbriar Farm Drive</u> add stop bars on all approaches and centerline striping on Oakwood Farms Lane approaches
- <u>Location 12: Ramsey Lane and Vail Court</u> add stop bar and pedestrian crosswalk to east leg, refresh stop bar and centerline striping on Ramsey Lane
- <u>Location 13: Ramsey Lane at Manchester Road</u> add pedestrian crossing and refresh stop bar across Ramsey Lane, moving back stop bar and stop sign if necessary for new crosswalk
- Location 14: Ries Bend Road at Ries Road refresh existing crosswalk and stop-bar striping
- Location 15: Ries Bend Road at Ries Road refresh existing crosswalk and stop-bar striping
- <u>Location 20: Westglen Village Drive and Westrun Drive</u> add stop bars to Westrun Drive approaches, add crosswalks across all approaches
- <u>Location 21: Westrun Drive and Terrington Drive</u> add stop bars to all approaches, add crosswalk across Terrington Drive approach, add centerline striping to Westrun Drive approaches
- Location 22: Windcliffe Drive and Towercliffe Drive add stop bar to Towercliffe Drive
- <u>Location 23: Windcliffe Drive and Portwind Place</u> add stop bars and centerline striping to Portwind Place approaches



### **Proposed Phase 2 Scope and Fee Estimate**

Phase 2 of the Ballwin Signage Study will, therefore, include an engineering study to determine whether stop signage is warranted as it exists at thirteen of the study locations as listed in the previous section. These study locations are listed in **Table 2**, below. At each of these locations, the engineering studies will require site observations, traffic volume data collection, warrant analyses, and potentially operational analyses.



Referring to the original plan for the overall Ballwin Signage Assessment project, Phase 2 is anticipated to include the tasks listed below. Data collection for the study sites will be the most significant task, ideally obtaining 24-hour counts of all traffic entering each of the thirteen locations. It is estimated that the data collection, evaluation, and documentation of the thirteen study locations (Tasks 1-5) will amount to approximately \$20,000 in total fee (not including the optional task), including \$6,500 for data collection. Development of a Policy Manual for the City (Tasks 6-7) is estimated to amount to \$5,000 in total fee.

#### PROPOSED PHASE 2 TASKS:

- Kick-off meeting with City and Ballwin PD staff: review Phase 1, collect any additional or new information pertaining to Phase 2. Discuss preferences for governing Policy with City and PD staff including applicability of previous policy (approved February 1997) and related classification designations.
- 2. Collect traffic data (i.e. volume data) as specified in Phase 1 for individual site assessments.
- 3. Utilize guidance provided by the Manual on Uniform Traffic Control Devices (MUTCD), the Missouri Department of Transportation (MoDOT) Engineering Policy Guide (EPG), and St. Louis County Department of Transportation's Publications and Manuals to assess the individual site locations identified and prioritized in Phase 1. Perform traffic operational analyses as required for assessment. Consider geometric or other changes that would mitigate issues in addition to/in lieu of signage.
- 4. Summarize the methodology, findings, and recommendations for specified locations in a memorandum to be submitted to City staff. The summary will include any identified geometric modifications with estimated construction costs and implementation priorities.
- 5. Meet with City staff and Ballwin Police Department Traffic Safety Unit to discuss analysis findings, alternatives, and recommendations.
- > (Optional Task) If design modifications are identified, develop preliminary plans at high-priority locations.
- 6. Utilizing process and findings from Phase I, coordinate with Ballwin PD Traffic & Safety Unit and City staff to identify appropriate implementation strategies and alternatives. Identify any short- or long-term program goals for stop signage within the City.
- 7. Prepare a Final Report for submittal to the City documenting the final recommendations for stop sign strategies, including installation and potential enhancements and program goals and priorities where appropriate. Create a clear and concise policy (shelf reference document) for future stop signage implementation.





I trust you will find this report useful as a Phase 1 summary of existing conditions and concerns regarding City of Ballwin stop signage, short-term recommendations, and a scope for the second Phase of the project to confirm long-term solutions. # **APPENDIX B**

City of Ballwin Official Policy: Stop Sign Installation



#### STOP SIGN INSTALLATION

Approved: February 24, 1997

This policy establishes warrants that must be met to justify the installation of stop signs on city-maintained streets. Requests for stop signs on city-maintained streets shall be submitted in writing to the City Administrator. Upon receipt of the request, the Police and Public Works Departments will determine if the location satisfies these warrants.

### **SECTION 1 - CLASSIFICATIONS:**

### Federal, State and County Roadway Systems:

Streets maintained by the United States Government, State of Missouri, or St. Louis County.

### City Arterial Roadway Systems:

Streets or combinations of street segments that intersect a Federal, State, County or other local arterial roadway at each end, but not the same street, and where parking is prohibited.

### Collector Roadway Systems:

Streets or combination of street segments of streets that intersect a Federal, State, County, or other local arterial roadway at each end (but not the same street) and where parking is allowed.

### Residential Streets:

All other streets whose purpose is to serve the adjoining properties or other subdivision streets.

### **SECTION 2 - STOP SIGN WARRANTS:**

### Federal, State, County and City Arterial Roadway Systems:

Warrants established by the appropriate agency (Manual of Uniform Traffic Control Devices).

### Collector Roadway Systems:

The Chief of Police and the City Engineer shall determine if the following warrants have been satisfied and prepare a joint recommendation.

- 1. Federal warrants for stop sign installation contained in the <u>Manual of Uniform Traffic Control</u> Devices shall be met.
- 2. Existing conditions meet the federal warrants listed in the <u>Manual of Uniform Traffic Control</u> <u>Devices</u>, or
- 3. Accident history at the intersection in question for the current year and the year just past reflects three (3) or more reported accidents of the type susceptible to correction by the installation of a stop sign, including right and left turn and right angle collisions indicate an accident problem, or
- 4. Where the application of the normal right-of-way yield is unduly hazardous due to a sight distance problem, or
- 5. Where other concerns are expressed by the City Engineer following an engineering study of the location in question, and where installation of a stop sign is determined to be the appropriate action. Traffic volumes shall be considered if the volumes on the lessor, or cross street, exceeds 50% of the volume on the City arterial or collector roadway.

#### Residential streets:

Residential stop signs will be considered if the following conditions are met:

1. An accident problem exists, as indicated by five or more reported accidents of a type susceptible to correction by a multiway stop installation occurring within a 12-month period. Such accidents include right and left-turn collisions as well as right-angle collisions.

#### OR

- 2. These minimum traffic volumes exist:
  - (a) The total vehicular volume entering the intersection from all approaches must average at least 500 vehicles per hour for any 8 hours of an average day, and
  - (b) The combined vehicular and pedestrian volume from the minor street or highway must average at least 200 units per hour for the same 8 hours, with an average delay to minor street vehicular traffic of at least 30 seconds per vehicle during the maximum hour, but
  - (c) When the 85-percentile approach speed of the major traffic exceeds 40 miles per hour, the minimum vehicular volume warrant is 70 percent of the above requirements.
- 3. A field investigation by staff is conducted to validate enforcement and physical factors, such as sight visibility.
- 4. A petition of support is presented to the City Clerk indicating that a significant number of property owners or residents who may be affected by the stop signs are supportive of this measure.

#### OR

5. Notwithstanding the above, the Board of Aldermen reserves the right to consider stop sign requests based on unique factors such as significant pedestrian activity, proximity of other traffic control devices and/or overriding safety considerations. Approval requires a super majority affirmative vote of the Board of Aldermen.

### **SECTION 3 - DESIGNATIONS:**

#### Federal, State, and County Roadway Systems:

Manchester Road (MO Route 100), Clayton Road, Baxter Road, New Ballwin Road (south of Twigwood Drive) and Oak Street.

### City Arterial Roadway Systems:

Holloway Road, Kehrs Mill Road, Henry Road, Steamboat Lane, Hillsdale Drive, West Skyline Drive, Ries Road, Ramsey Lane, Old Ballwin Road, New Ballwin Road, and Reinke Road.

### Collector Roadway Systems:

Castle Pines Dr./Ct., Mayfair Drive (between Clayton Road and Nottingham Drive), Nottingham Drive (between Mayfair Drive and Del Ebro Drive), Del Ebro (between Nottingham Drive and Kehrs Mill Road), Claymont Drive, Sudbury Drive, Greenbriar Drive, Country Club Drive, Clear Meadows Drive, Hill Trail Drive, Wildwood Parkway, Trail Wood Drive, Old Oaks Drive, Iron Lantern Drive, Gatehall Drive (between Iron Lantern Drive and Henry Road), Forest Leaf Drive (between Baxter Road and Brass Lamp Drive), Brass Lamp Drive, Spring Meadows Drive, Clayworth Drive, Shady Meadows Drive, Seven Trails Drive, Dutch Mill Drive, Windcliffe Drive, Towercliffe Drive, Portwind Drive (between Windcliffe Drive and Treasure Cove), Treasure Cove, Cleta Drive, Twigwood Drive, Rustic Valley Drive, Westglen Village Drive, Westrun Drive, Aspen Village Drive, Woodrun Drive (between Westrun Drive and New Ballwin Road), St. Joseph Drive, Ballwin Commons Drive, Mimosa Drive, Burtonwood Drive, and Portsdown Drive (between Mimosa Drive and Burtonwood Drive).


