

Our central location is conveniently located within 10 miles of Interstates 44, 64, and 270. The City of Ballwin is a very connected community!

Airport

It's a quick, 26-minute ride from Ballwin to the St. Louis Lambert International Airport, the largest and busiest international airport in Missouri. We are also just 6 miles away from the Spirit of St. Louis Airport, located in the neighboring City of Chesterfield.

Schools and Universities

Ballwin is served by AAA-rated school districts, Rockwood and Parkway. We are also located within 30 minutes of several major universities and colleges, including Webster University, Lindenwood University, Maryville University, Logan University, Missouri Baptist University, Fontbonne University, University of Missouri - St. Louis, and Washington University.

BUSINESS DISTRICT

The City of Ballwin is a very welcoming community that is continuously working to grow and enhance our business district. Our current business district is made up of over 300 businesses, ranging from small boutiques to national corporations such as Target, Lowe's, and Old Navy.

Ballwin sits directly off of Route 100 (commonly referred to as Manchester Road), a heavily-trafficked, 121-mile long, state highway. We have several shopping centers and city plazas, many located right off of the Manchester Road corridor. Our major plazas include Old Towne Plaza, Central Plaza, Ballwin Plaza, Gordon Plaza, Ballwin Village, Claymont Center, and Ballwin Grove Plaza.

There is a wealth of restaurants, shopping, and service-based businesses in Ballwin. While we pride ourselves on having everything you could ever need within our city limits - there is always room to grow with your business!

Business Services

Once your Ballwin business is open, you'll find there are a variety of tools and resources to aid in your business' success, including the local West County Chamber of Commerce and our free Shop Ballwin First marketing program. We also offer a 0% municipal property tax, discounted rates to our community center, and after-hours emergency partnerships with our Police Department.
