Re: Transparency Portal

About a year ago, I brought up the issue of city budget and expense transparency. I recommended at that time that we investigate a website application that would allow citizens the ability to look at the city's financials, expenses, salaries and other metrics that indicate the health of our city financials. At that time, I remember the positive comments about this idea, but we were switching over to new accounting software for the city and many felt this was not a good time to add one more thing on staff to do. Further discussion was needed. So now is that time.

At that time, I recommended an application that the Mehlville fire department implemented years ago and is using today. A copy of the screen shots of this application from their website is included. As you can see from this handout, that the "Transparency Portal" allows anyone to search the fire district's financials, salaries, and budgets easily and helps identify where resident's tax dollars are being spent and not spent. With the portal search capabilities you can search by vendor, dollars spent, date, rank high to low, etc. It is a useful transparency tool for both board use and residents to see how our money is being spent and where their tax dollars are being allocated.

I will talk more about this at the board meeting on Monday night, but I wanted you to see the handout before the meeting and give you a chance to go to the Mehlville Fire District website and investigate this amazing application. The creator/vendor of this application is located in the Fenton area. I believe with the sophistication of our new accounting software that this should be an easy merge of the two platforms. If a small fire district could do this, I would think that we could make this work if we want it work. I believe we need to be on the cutting edge of financial transparency. We have a good story to tell.

P.S This idea is being replicated in different cities and fire districts across the area. Monarch Fire Dist. voted a few weeks ago to adopt this "Transparency Portal" as well.


