## **Approval of Minutes**

## **SUE 20-11 – Automotive Service/Repair including Bodywork**

Champion Car Care Automotive Repair, 15230 Manchester Road *Petitioner: Kristine Goehl, 300 Ries Bend Rd, Ballwin MO 63021* 

Mr. William Goehl addressed the Commission, requesting approval for the Special Use Exception. He stated that the primary business is paintless dent repair, with some auto repair. This will be their second location.

Chairman Weaver asked about the hours of operation. Mr. Goehl said the facility will be open Monday through Saturday, with the hours Monday-Friday being 8:30 am - 5:30 pm, and 10:00 am - 2:00 pm on Saturday.

Mayor Pogue asked Mr. Goehl if he had an opportunity to review the Petition Review Report. Mr. Goehl said that he had received the report and will comply with all criteria and recommendations of staff. Mayor Pogue asked if the petitioner is planning any site improvements. Mr. Goehl said there will be no change.

Alderman Roach asked Planning Technician Edghill asked why this petition is before the Commission. Mr. Edghill said the previous SUE had expired, necessitating this petition.

Chairman Weaver opened the public hearing and asked if anyone wished to speak in favor of Petition SUE 20-11. No one came forward. Chairman Weaver asked if anyone wished to speak in opposition to the petition. No one came forward, and Chairman Weaver closed the public hearing.
