

## **CONSENT ITEM**

**RE:** Purchase of Four ADA Compliant Pool Lifts

**DEPARTMENT:** Parks and Recreation

**PROGRAM:** Pointe and North Pointe Aquatic Center

**RECOMMENDATION:** Recommend the purchase of four ADA compliant pool lifts per specifications from the low bidder, Pool and Electrical Products, in the amount of \$13,974.35.

**EXPLANATION:** In 2010 the aquatic component of the American's with Disabilities Act was finalized mandating new accessibility guidelines for new pool construction as well as existing pools. To bring the pools at The Pointe and North Pointe into compliance with this federal law, one new lift must be purchased for The Pointe and three new lifts for North Pointe. Total 2013 budget for purchase of the lifts is \$18,500. This bid was formerly advertised and 12 bids were received and opened by staff on February 15, 2013.
