

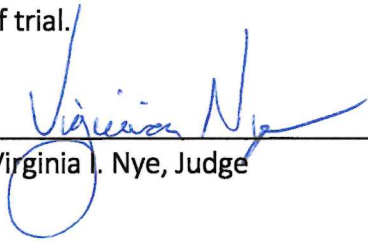

ORDER

1. I am the Municipal Judge for the City of Ballwin and City of Winchester, Missouri, a municipal division of the 21st Judicial Circuit of Missouri.
2. I have original jurisdiction over animal control violations, housing violation and traffic violations in this municipal division.
3. This court has previously established a violations bureau (subject to the supervision of the circuit court and consistent with Missouri Law) that includes all of the violations set out in paragraph 2, above.
4. I hereby designate Mikki Grieshaber as the violations bureau clerk. It shall be her duty to accept appearances, waivers of trial, pleas of guilty and payment of fines and costs for the designated violations, enter the pleas on the record and transmit the violation records as required by law.
5. I hereby adopt the Violation Bureau Schedule of Fines as attached which is consistent with Rule 37.495.
6. A person may pay the specified amount of the fine and costs to the bureau in person, by mail or through an electronic payment system before the court date and time for the initial court appearance. Said payment constitutes a guilty plea and waiver of trial.

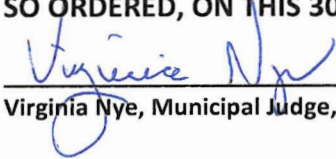

In court, the Judge may assess a fine from \$1.00 to \$193.50 per violation. **Any citation involving an accident must appear in Court.** Costs include \$12.00 court cost, \$7.50 Crime Victims' Comp Fund Surcharge, \$2.00 Inmate Security Fund, \$2.00 Police Training Fund (Ballwin Only), \$1.00 Peace Officer Training Fund, \$2.00 Domestic Violence Fund (Winchester Only), \$7.00 State Court Automation Fee.
