ADA Transition Plan for Public Rights-of-Way

Introduction

The Americans with Disabilities Act (ADA), enacted on July 26, 1990, is a civil rights law prohibiting discrimination against individuals on the basis of disability. The ADA consists of five titles outlining protections in the following areas:

- I. Employment
- II. State and local government services
- III. Public accommodations
- IV. Telecommunications
- V. Miscellaneous Provisions

Title II of the ADA is a section that pertains to the programs, activities and services public entities provide. Because City of Ballwin provides public services and programs, the organization is committed to comply with this section of the Act as it specifically applies to local government transportation agencies. Title II of the ADA provides that, "...no qualified individual with a disability shall, by reason of such disability, be excluded from participation in or be denied the benefits of the services, programs, or activities of a public entity, or be subjected to discrimination by any such entity." (42 U.S.C. Sec. 12132; 28 C.F.R. Sec. 35.130)

As required by Title II of the ADA, City of Ballwin is conducting a self-evaluation of its facilities and has developed this Transition Plan detailing how the organization will ensure all sidewalks within public street rights-of-way are accessible to all individuals.

ADA and its Relationship to Other Laws

Title II of the ADA is companion legislation to two previous federal statutes and regulations; the Architectural Barriers Acts of 1968 and Section 504 of the Rehabilitation Act of 1973.

The Architectural Barriers Act requires access to facilities designed, built, altered or leased with Federal funds. Passed by Congress in 1968, it marks one of the first efforts to ensure access to the built environment.

Section 504 of the Rehabilitation Act of 1973 is a federal law that protects qualified individuals from discrimination based on their disability. The nondiscrimination requirements of the law apply to employers and organizations that receive financial assistance from any Federal department or agency. Title II of the ADA extended this coverage to all state and local government entities, regardless of whether they receive federal funding or not.

When addressing accessibility needs and requirements it is important to note that the ADA and Title II do not supersede or preempt state or local laws that may offer equivalent or greater protections.

Program Location and Support

Staffing

The City will assign responsibility for compliance to the Director of Public Works (Director). The Director is responsible for developing policy and procedure to integrate Title II requirements into City of Ballwin practices to ensure the obligations of ADA and the transition plan can be met. The Director will also function as chair of the Internal ADA committee.

Americans with Disabilities Act Advisory Committee (ADAAC)

The City of Ballwin convened an internal advisory committee with representation from a cross section of functional areas to assist in the development of policy and practice to integrate ADA into City of Ballwin project delivery and operations. The ADAAC shall meet twice per year. The functions that make up ADAAC's membership follows:

- Director of Public Works
- Street Superintendent
- Street Foremen

Each individual on the committee is responsible for notifying the Director of any ADA issues or concerns in their area of responsibility. The Director is responsible for tracking ADA requests in the City and ensuring compliance with the ADA Sidewalk Transition Plan and policies.

The City will assign responsibility for compliance to the Director. The Director is responsible for developing policy and procedure to integrate Title II requirements into City of Ballwin practices to ensure the obligations of ADA and the transition plan can be met. The Director will also function as chair of the Internal ADA committee.

Transition Plan Management

City of Ballwin's transition plan is a **living** document that will be updated on a regular basis, as appropriate. The first formal update to the City of Ballwin ADA Sidewalk Transition Plan is scheduled to occur two years from the plan's formal adoption and on a five year cycle thereafter. At the recommendation of the Director, the update schedule may be altered at the discretion of the Board of Aldermen.

To streamline the updating process and keep the document current and relevant, appendices will be updated annually if new information is available and does not alter the intent of the transition plan.

Grievance Procedure

Under the Americans with Disabilities Act, users of City of Ballwin facilities and services have the right to file a grievance if they believe the City has not provided reasonable accommodation. All complaints should be presented in writing to City of Ballwin's City Administrator.

Please consult the Grievance Procedure found in Appendix A or City of Ballwin's website at www.ballwin.mo.us for details. A formal complaint must be filed within 180 calendar days of the alleged occurrence. City of Ballwin will not officially act or respond to complaints made verbally.

Communications

According to Section 35.160(a) of the ADA, "...A public entity shall take appropriate steps to ensure that communications with applicants, participants, and members of the public with disabilities are as effective as communications with others." This means that City of Ballwin is required to provide equally effective communication to individuals with disabilities. Equally effective communication can be provided by offering alternative formats, auxiliary aid(s) and/or services upon request. For example, interpreters may be hired as requested, or as needs are identified, for the hearing impaired.

Self-Evaluation

As required by Title II of ADA, City of Ballwin must conduct a self-evaluation of physical assets and current policies and practices. As inventories are completed they will be included as appendices to the transition plan and modified ongoing, as appropriate.

Curb Ramp and Sidewalks

As a minimum, the City of Ballwin will upgrade curb ramps and sidewalks to PROWAG standards in conjunction with street resurfacing, microsurfacing, and extensive concrete pavement replacements. Approximately 30 curb ramps will be upgraded annually.

Policies

City of Ballwin is committed to reviewing its policies and procedures to ensure they comply with ADA Title II and Section 504.

Correction Program

All new construction, reconstruction, resurfacing, microsurfacing, and alteration to Ballwin maintained street rights of way will include accessibility needs in the project's scope per ADA requirements. All curb ramps will be update to current regulations and tripping hazards eliminated.

Training

Following formal adoption of the City of Ballwin ADA Transition Plan, the ADA Advisory Committee (ADAAC) will conduct department-wide training on the policies and procedures outlined herein. As a key element of the training, all employees designated as ADA Compliance Assistants will receive more in-depth training on how to assist and respond to ADA accommodation requests, general concerns, and grievances. In light of personnel changes that may occur from time to time, the Director will monitor and ensure there is an adequate number of ADA Compliance Assistant's throughout the City's Public Works Department ongoing. As the training is completed, documentation will be retained in Appendix B of this Plan document.

APPENDIX A

AMERICANS WITH DISABILITIES ACT (ADA)

Grievance Procedure

The City of Ballwin has adopted a grievance procedure for prompt and equitable resolutions of complaints alleging any actions prohibited by the Americans with Disabilities Act (ADA).

Grievances should be addressed to the City Administrator's office. There are other employees designated to assist with ADA efforts within the City too.

This form describes the manner in which any person may bring a complaint (referred to as a grievance) regarding the accessibility of facilities, programs, and services of the City of Ballwin. This process is intended to comply with Section 35.107 of the Department of Justice rule (28 CFR Part 35) implementing Title II, Subtitle A of the Americans with Disabilities Act (P.L. 101-336).

STEP 1: Any person either having a disability, associated with a person having a disability or regarded as having an impairment may file a grievance with the City of Ballwin. The grievance may be made by completing this form or you can file your grievance in writing to the city. Your written grievance to the City of Ballwin should include the following information:

- Name of person filing the grievance.
- Address and telephone number of person filing the grievance.
- Address of the person making the grievance (if different from address person filing grievance);
- Date, time, and location of circumstance or incident;
- Description of how the city, department or staff member discriminated on the basis of disability including the date, time and location of the incident.
- The change, correction, remedy, action, or relief sought by the person filing the grievance.
- The signature of the person filing the grievance.

STEP 2: The grievance should be filed with the City of Ballwin's City Administrator's office within 180 days after the person filing the grievance becomes aware of the alleged violation(s) of ADA regulations. Within three (3) business days of its receipt of the grievance, the city must attempt to arrange a conference with the person filing the grievance. The conference must be conducted within ten (10) business days of the city's receipt of the grievance. Before and after the conference, the ADA Coordinator, with possible assistance from designated employees, must investigate the grievance and examine actions which the department can take to address the grievance.

STEP 3: Within five (5) business days of the conference, the ADA Coordinator will inform the person filing the grievance as to how and when the City will respond, or whether the City will take any action with respect to the grievance. This notice to the person filing the grievance must be in writing or in another permanent and effective means of communication and must be mailed or delivered to the last known address of the person filing the grievance.

STEP 4: If the person filing the grievance finds the City's response to be unsatisfactory, he/she may, within five (5) business days of receipt of the City's response, request that the grievance be reconsidered. A request for reconsideration must be in writing and be filed with the ADA Coordinator's designee.

A. Reconsideration will be made by the ADA Coordinator's designee. Within ten (10) business days of the department's receipt of a reconsideration request, the ADA Coordinator's designee may take such action as investigating the grievance, interviewing employees or meeting with the person filing the grievance, if deemed necessary to the reconsideration of the request.

B. A written notice of the decision of the ADA Coordinator's designee must be made no later than twenty (20) business days from the receipt of the request for reconsideration. This notice must be mailed or delivered to the last known address of the person making the reconsideration request.

The right of a person to prompt and equitable resolution of the complaint filed under this procedure shall not be impaired by the person's pursuit of other remedies, such as the filing of an ADA complaint with the responsible federal agency. Use of this procedure is not a prerequisite to the pursuit of other remedies.

These rules shall be constructed to protect the substantive rights of interested persons, to meet appropriate due process standards, and to assure that the City of Ballwin complies with Americans with Disabilities Act.
